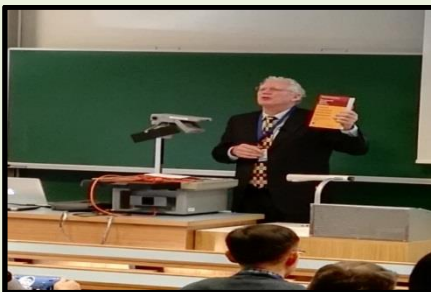

Peter G. Szilagyi is an Associate Professor of Finance and Director of the MSc in Finance at CEU Business School in *Central European University*, Hungary. He maintains a fellowship at Judge Business School, *University of Cambridge*, where he served in 2007-2014. He has been an external fixed-income consultant to the *World Bank* and the *Asian Development Bank*. Peter's research interests include corporate finance, corporate governance, international finance, and law and economics. His researches are published in journals such as *Journal of International Finance Markets, Institutions & Money; Emerging Markets Review; Journal of Corporate Finance; European Financial Management; and Quantitative Finance*. Furthermore, he is the Editor of Elsevier's *Journal of Multinational Financial Management*, and Subject Editor of *Emerging Markets Review* and the *Journal of International Financial Markets, Institutions & Money*. He holds a PhD in Finance from Tilburg University.
