On behalf of EBES, we would like to wish you a happy new year filled with prosperity, contentment and successful research. While 2018 has been marked by noteworthy achievement, 2019 promises to be an exciting year as well and we are looking forward with enthusiasm to next year at EBES. We are getting bigger and bigger each day! Thank you for your interest and support. EBES now has over **1998** members from **84** countries. Since our first conference in 2009, around **10,949** colleagues from **98** countries have joined our conferences and **6,273** academic papers have been presented.



2019 is coming with changes in EBES management. As you might have heard from us in our conferences, **Prof. Klaus F. Zimmermann** (UNU-MERIT, Maastricht University) will replace **Prof. Jonathan Batten** as the President of EBES starting Jan 2019. We would like to thank both **Prof. Batten** and **Prof. Rangazas** for their support and contribution to our journals and EBES and are looking forward to working with them in their new roles at EBES.

Also, we are happy to announce that a distinguished scholar, **Prof. Amine Tarazi**, has recently joined our advisory board. **Prof. Tarazi** is a professor of Economics and Finance at the *University of Limoges* (France) where he is currently the Director of a research center, LAPE, and Head of the Economics department.

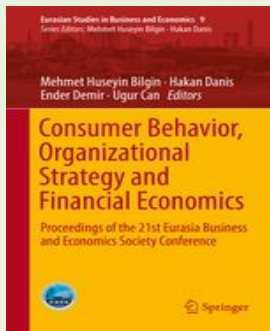


### EBES Journals

Latest issues of *Eurasian Business Review* **8(4)** and *Eurasian Economic Review* **8(3)** have been published. Please visit the webpages of the journals for details.

We are also very proud to announce that 2017 *Scopus Cite Score* for ***Eurasian Business Review (EABR)*** is **1.39**. This value is greater than the scores of some well-established and long-term reputed economic journals. By November 2018, CiteScore of the journal has increased to **1.89**. *EABR* is ranked as the **16th** among 86 journals in the field of “Economics, Econometrics and Finance” and **52nd** among 195 journals in the field of “Business, Management and Accounting”. Similarly, 2017 *CiteScore (Scopus)* of ***Eurasian Economic Review (EAER)*** is **0.88**. *EAER* is ranked **51st** among 190 journals in the field of “General Economics, Econometrics and Finance”.

### EBES Proceedings



*21st EBES Conference - Budapest proceedings* have been published recently. Since our 13th Conference, EBES conference proceedings have been published by Springer under its series *Eurasian Studies in Business and Economics*. Each proceeding is sent to *Clarivate Analytics* in order to be reviewed for coverage in its Conference Proceedings Citation Index. Please note that the 10th, 11th, 12th, 13th, 14th, 15th, 16th, 17th, 19th and 20th (Vol. 2) EBES Conference Proceedings have been accepted for inclusion in the *Conference Proceedings Citation Index - Social Science & Humanities (CPCI-SSH)*. 18th, 20th (Vol. 1), 21st and subsequent conference proceedings are in progress.
