We are pleased to announce that distinguished colleagues **Marco Vivarelli**, **Luigi Campiglio**, and **Euston Quah** will join the conference as keynote speakers:



Marco Vivarelli is a professor of economics at the *Università Cattolica del Sacro Cuore* in Milano, Italy. He is currently the Editor-in-Chief of the *Eurasian Business Review*, associate editor of the *Industrial and Corporate Change*, *Small Business Economics*, the electronic journal: "economics" and *Economia e Politica Industriale - Journal of Industrial and Business Economics*. His current research interests include the determinants of R&D activities; the relationship between technological and organizational change, employment and skills; the labor market and income distribution impacts of globalization; and the entry and post-entry performance of newborn firms. Professor Vivarelli holds a PhD degree in science and technology policy from *SPRU-University of Sussex* and in economics from *Pavia University*.



Luigi Campiglio is a professor of economic policy at the *Catholic University of Milan*. He was a visiting scholar at *Stanford University* and overseas fellow of the *Churchill College* in Cambridge. He was a member of the *National Research Council* for the national project evaluation in economics twice. Having been the Vice-Rector of the *Catholic University of Milan* from 2002 to 2010, he is currently the Editor-in-Chief of the *Economic Review* of the university. His main research topics have focused on economic growth, inflation, income distribution, welfare systems, saving, demography. More recently, his research has been concerned with macro issues related to the European economy and its economic imbalances. He published papers in national and international journals, books, and textbooks.



Euston Quah is professor of economics and head of the Department of Economics at the *Nanyang Technological University*, Singapore. He is a prolific writer with publications in well-known international journals such as *World Development*, *Applied Economics*, *Environment and Planning*, *Journal of Environmental Management*, *International Review of Law and Economics*, *Journal of Economics*, *Journal of Public Economic Theory*, *American Journal of Economics and Sociology*, among others, and some 6 books. **Professor Quah** is editor of the *Singapore Economic Review* and co-editor of *International Gambling Studies*.
