He also is an associate editor of *Journal of Banking and Finance*. He worked as an economist in the Department of Health and Central Bank in Ireland and has more than 150 peer-reviewed papers, which were published in reputable finance journals including *Journal of International Financial Markets, Institutions and Money*; *Journal of Banking and Finance*; *Journal of Financial Stability*; and *Journal of Multinational Financial Management*.
