Dear EBES Members,

Thank you for your interest and support. EBES now has over **2106** members from **84** countries. Since our first conference in 2009, around **11,460** colleagues from **98** countries have joined our conferences and **6,546** papers have been presented.

Eurasian Business Review (EABR), one of EBES's official journals, was recently assigned an Impact Factor of **2.143** (2018 JCR Impact Factor) which puts it in the top quartile among "Economics" journals. EABR is published quarterly and currently indexed in *Social Science Citation Index (SSCI)* in addition to *SCOPUS* and other leading indexes.

He also is an associate editor of *Journal of Banking and Finance*. He worked as an economist in the Department of Health and Central Bank in Ireland and has more than 150 peer-reviewed papers, which were published in reputable finance journals including *Journal of International Financial Markets, Institutions and Money*; *Journal of Banking and Finance*; *Journal of Financial Stability*; and *Journal of Multinational Financial Management*.
