The conference will take place on August 5th, 6th and 7th, 2020 at *Kadir Has University* in Istanbul, Turkey. In addition to oral presentation, there will be online/virtual presentation options for the *32nd EBES Conference* participants who are unable to attend the conference in person.

1. **Virtual:** Those who would like join us via virtual presentation should email us their “voice over power point” presentation.
2. **Online (live presentation):** Those who would like to join us via online (live) will be able to present their papers live. The conference will start with the Opening and Keynote Speeches, which will be followed by the regular parallel sessions. Each session will have a session chair and 5 to 6 presenters. Each presenter will have 20 minutes for presentation and 5 minutes for Q/A.
