The Impact Factor and CiteScore statistics for 2022 have been announced! We are pleased to share that our journals, Eurasian Economic Review (EAER) and Eurasian Business Review (EABR), achieved great results!

### **Eurasian Economic Review (EAER)**

**EAER** has received **5.5** according to the *Citescore 2022* metrics of Scopus, ranking the journal in the **1st quartile**. **EAER** has also received its first Impact Factor of **3.4** in 2022 and got a ranking in Economics in **1st quartile** (WoS). The progress of the **EAER** over the years is as follows.


