47th EBES Conference - Berlin

April 18-20, 2024

Abstract Submission Deadline: February 29, 2024

47th EBES Conference – Berlin will take place on April 18th, 19th, and 20th, 2024 in Berlin, Germany. It will jointly be organized with *GLO (Global Labor Organization)* with the support of the *Istanbul Economic Research Association* and in collaboration with the *FOM University of Applied Sciences*. The conference will be held in a hybrid mode. The first two days of the conference (April 18th and 19th) will be in-person and the last day will be online. Thus, participants can either attend the sessions and present their papers face-to-face at the conference venue or choose to do the same through online platforms. Abstract submission for the *47th EBES Conference* is now open. For online submission, please visit <https://ebesweb.org/47th-ebes-conference/berlin-abstract-submission/>.

In addition to the regular sessions organized by EBES and GLO, the conference will host several special sessions. During the conference, EBES will dedicate a session to honoring the life-long achievements of our president, Klaus F. Zimmermann, and celebrating his work. Additionally, the conference will feature leading scholars in their respective fields as invited speakers, sharing insights and recent trends from their disciplines. Furthermore, two other sessions, namely the "Editors Session" and "Publisher Session", will be conducted to provide insights from SSCI journal editors and Springer publishers regarding the editorial and publishing processes.
